2.1. At the initiative of the client, prior to expiry / replacement of lost / stolen card	1 000 tenge

3.1.1. Salary, deposit/loan (credit) funds	0 tenge
3.1.2. Other than salary, deposit/loan (credit) funds	up to 1,000,000 tenge per month – 0 tenge; above – 1% of amount (equivalent in another currency)
3.2. ATMs of other banks within Kazakhstan <sup>2;5</sup>	up to 500,000 tenge per month – 0 tenge; above – 0.6% of amount
3.3. ATMs of banks outside Kazakhstan <sup>2</sup>	up to 200,000 tenge per month – 0 tenge; above – 1% of amount, minimum 500 tenge
3.4. At Bank cash desks (via POS-terminal without use of physical card):	
3.4.1. Salary, credit and deposit funds	0 tenge
3.4.2. Other credits (excluding salary, credit and deposit funds)	up to 1,000,000 tenge per month – 0 tenge; above – 1% of amount, minimum 500 tenge
3.4.3. At other banks' cash desks within Kazakhstan (via POS-terminal without card)	0,5% + 500 tenge
3.4.4. At other banks' cash desks outside Kazakhstan (via POS-terminal without card)	0,5% + 1000 tenge
<b>4. Transfer operations from payment card/account/phone number (within Bank's network):</b>	
4.1 To payment card/phone number: <sup>3</sup>	
4.1.1. Of a Kazakhstan resident bank	up to 300,000 tenge per month (inclusive) – 0 tenge; above – 0.2% of amount, minimum 200 tenge
4.1.2. To a foreign bank payment card	0,5% of amount + 400 tenge
4.2. Bank transfers to individuals' bank accounts	0 tenge
<b>5. Additional services:</b>	
5.1. SMS-Banking service (account maintenance via sms/push notifications on mobile phone regarding payment card/account transactions):	
5.1.1. Connection / disconnection (incl. VAT)	0 tenge
