<b>Transactions with securities on the domestic over-the-counter market</b>	
Buy/sale from 100* mln. tenge - up to 500 mln. tenge	0,05% of the transaction amount
Buy/sale from 500 mln. tenge - up to 10 bln. tenge	0,03% of the transaction amount
Buy/sale over 10 bln. tenge	0,01% of the transaction amount
<b>Transactions with securities on the international market (exchange/non-exchange)</b>	
from 250* mln. tenge - up to 5 bln. tenge (equivalent of the transaction amount in currency)	0,3% of the transaction amount
from 5 bln. tenge - up to 10 bln. tenge (equivalent of the transaction amount in currency)	0,2% of the transaction amount
from 10 bln. tenge - up to 25 bln. tenge (equivalent of the transaction amount in currency)	0,10% of the transaction amount

Issuance of reporting documents from the personal account	once a month free of charge; additionally at the client's request (for each additional reporting document) - 7,000 tenge
Registration/removal of encumbrance	15 000 tenge
